## Dealer Terms and Conditions (Cont'd)

### Standard Terms

All prices extended to dealers are FOB Polson, Montana USA.

Net 30 day terms are extended to Authorized Dealers approved for credit. Overdue balances will bear 1.5% per month interest charge and any dealer past 30 days will be considered delinquent and no orders will be shipped until the dealer is current again. In the event that any unpaid amounts become past due and GearPods incurs expenses to collect past due amounts, applicant agrees to pay all costs related to collection, including attorneys fees.

### Shipping

Shipping charges are calculated individually for each order and added to the invoice. In most cases freight will be prepaid with charges added to invoice. LTL shipments are sent freight collect. Please specify by which means order is to be shipped. GearPods will call you to confirm order and shipping charges before proceeding. All orders are subject to acceptance by GearPods.

All shipping claims and discrepancies must be reported within 5 days of receipt of order.

### Damaged Shipments

All claims for loss or damage on prepaid freight shipments will be handled through GearPods. All claims on freight collect shipments will be handled by the dealer directly with the freight company.

### Returned Goods

GearPods products are covered by a one-year warranty against manufacturing defects. Products will not be accepted for return unless specific authorization of such return has been given in advance by GearPods Customer Service.

### Authorized Dealer Policy

GearPods products are only sold through authorized dealers. The following activities are prohibited and will result in termination of dealer agreement:

- Trans-shipment of GearPods products to non-authorized dealers or e-commerce companies
- Offering GearPods products over internet auctions

### Minimum Advertised Prices

The minimum advertised price (MAP), as defined in the GearPods Price List/Order Form, sets the minimum price at which GearPods products can be sold by the dealer. GearPods monitors compliance to MAP prices and reserves the right to terminate the dealer agreement in the event that MAP prices are not followed.

### Third Party Kits

Selling third party kits built on the GearPods Connect™ system is prohibited. Please call us to discuss special terms.
